During the meeting, we were able to outline a plan and framework for the evaluation of QuICR's Door-to-Needle (DTN) initiative.

There are 2 quantitative analyses in the works: 1) a pre-post analysis using data from APSS (Alberta Provincial Stroke Strategy) for the pre-dataset and data from the QuICR registry for the post dataset with possible consideration of comparison of DTN times over the same period from another jurisdiction; 2) Analysis of the QuICR registry data to evaluate how much each process (e.g. Pre-notification and Direct-to-CT) reduced DTN time provincially.









A cursory qualitative pre-post analysis has been done and the abstract has been selected for an *Oral* presentation at the European Stroke Organization Conference to be held in Prague May 16-18 2017. [Kamal N, Jeerakathil T, Smith EE, Mann B, Hill MD on behalf of the QuICR Alberta Stroke Program. Reducing Door-to-Needle times at 17 hospital to 36 minutes. *European Stroke Organization Conference*. May 16-18 2017. Oral Presentation.]

There is also a full qualitative analysis planned of QuICR's DTN initiative. This will include conducting focus groups and interviews at the participating hospitals. There will also be a questionnaire developed to allow all participants to provide their feedback on QuICR DTN Improvement Collaborative process. A significant outcome from this meeting was the inclusion of a post-doctoral fellow from University of Calgary's Haskayne School of Business (Jo-Louise Huq), whose key research interest is in qualitative review of initiatives within the healthcare sector. Through this meeting, we were able to introduce Dr. Huq to this work, and she will be leading the qualitative component of the evaluation.

6. Please provide any additional commentary on the benefits or unexpected consequences arising from the meeting:

The key benefits that arose from this meeting were the relationships and buy-in from externals groups and departments that were not intrinsically part of the DTN Initiative. This includes both DIMR from AHS and the Haskayne School of Business. By having key representation from DIMR at AHS, we were able to understand the DTN initiative and the QuICR registry, and they are now quite excited to be a part of this work and support data linkages. This meeting also allowed for greater integration of the Haskayne School of Business into the evaluation of this work. There are faculty that are interested in each the qualitative and quantitative components of the analysis. Additionally, we were able to recruit Dr. Hug as a PDF to lead the qualitative analysis.
