The overarching objectives of the Forum were to:

- 1) Identify and explore opportunities and challenges posed by inter-professional and interorganizational collaboration, in order to facilitate greater collaboration for the benefit of patients;
- 2) Discuss challenges to implementing an integrated care model for seniors' care within the primary care setting;
- 3) Engage more seniors and caregivers in changing the healthcare system.

## 2. Meeting attendance (total number of attendees, affiliations represented, etc.):

A wide variety of stakeholders including administrators, frontline staff, patient and caregiver advocates attended the Forum, representing the following groups and organizations: Alberta Health, Alberta Health Services (AHS), Alzheimer Society of Alberta and NWT, Institute for Continuing Care Education and Research, University of Alberta, College and Association of Registered Nurses of Alberta, Pan-Edmonton Groups Addressing Social Isolation Impact Plan Services (PEGASIS), Seniors' Health Strategic Clinical Network, Edmonton Oliver Primary Care Network, Covenant Health and Misericordia Hospital, Toward Optimized Practice (TOP), Network of Excellence in Seniors' Health and Wellness, Adult/Seniors Strategy and Provincial Education Resources, Geriatric Assessment and Rehabilitation, Home Care and Continuing Care. The total number of attendees was 53, including 5 organizers and 4 patient representatives.

  - 1. (Ongoing) Collaboration with **HQCA/TOP teams** on developing a standardized patient care plan template and designing a scale and spread strategy within primary care networks.
  - 2. (Ongoing) Collaboration with **the Pan-Edmonton Group Addressing Social Isolation (PEGASIS)** to assist in linking the PEGASIS impact plan with primary healthcare teams.
  - 3. (Ongoing) Collaboration with **Better Choices, Better Health® Chronic Disease Self-management** to create care components for seniors for self management, health promotion and preventative health
  - 4. (Ongoing) Collaboration with **the AHS Nutrition Services** to create a standardized way to assess nutrition in seniors living with frailty and address one of the main modifiable contributing factors for frailty.
  - 5. (January March 2017) Collaboration with **Dr. Andrew Clegg and Sarah De-Biase (United Kingdom)** regarding implementation of the electronic frailty index (eFI) in Alberta, Canada.
  - 6. (Fall 2017) **Provincial Conference: Innovative Primary Care Models for Seniors' Health** that will be held on October 10th, 2017 in Red Deer. This conference will build on the work of the Improving Care Experience, Efficiencies and Quality of Care for Seniors in Alberta Forum. The results of the Forum will be used to tailor the agenda of the upcoming event, that is expected to be attended by 150 participants from a variety of organizations. This conference aims to heighten awareness of frailty and its impact on the health care system, showcase work being done by Central Zone and Edmonton Zone PCNs on Seniors' health and wellness, and focus on ways to improve the health status and care experiences of seniors in the community, while ensuring quality service delivery and cost effectiveness.

#### **Received funding:**

**Alberta Innovates Community Engagement and Conference Grant 2017** was awarded on February 27, 2017. This grant will cover costs of the Provincial Conference: Innovative Primary Care Models for Seniors' Health (see above).

Joint collaboration between the UK research team who created the eFI (Dr. Clegg and Sarah De-Biase et al), the Department of Family Medicine (University of Alberta), the Primary Health Care Innovation Network (SCN), and Industry partnership with Telus Health.
