5. List (with projected timelines and names of participants) what activities or next steps are ensuing from the meeting (follow-up meetings, etc):

Unfortunately the onset of the COVID-19 pandemic interrupted this group's plans to reconvene again ~2 months after our Feb 4 2020 meeting. However, a follow-up meeting was held on April 21, 2021, with 29 attendees. The group agreed to continue to meet regularly (~every 3-6 months), with a rotating chair model, as Dr. Sinnarajah (current Chair) is moving to Ontario later this year. Covenant Health's Palliative Institute has agreed to take over meeting planning logistics. We will continue to work on prioritizing the identified research projects, and then develop smaller working groups to implement them and/or seek funding to support them.

An infographic is also being developed that will be used to support grant applications and to advocate for future work, by highlighting the development of this community of practice and their research priorities.
